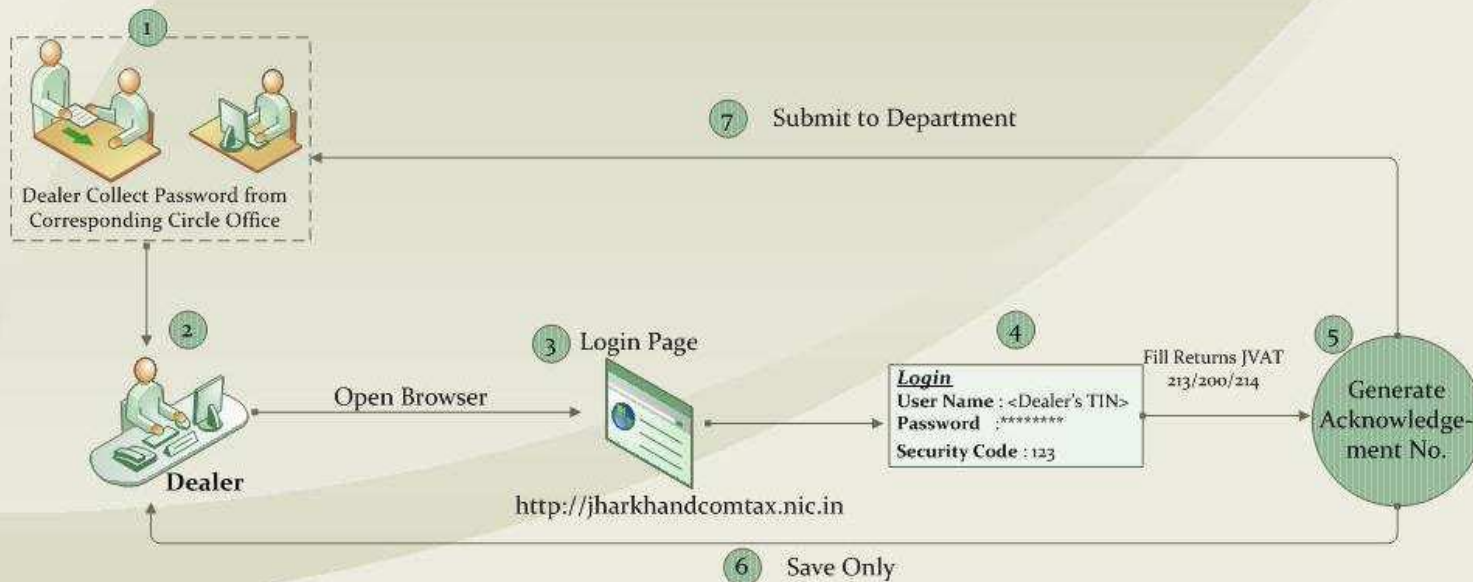


ONLINE RETURN FILING



On Line Return process

- 1 Dealer to Collect Password from Corresponding Circle Office
- 2 Browser to be opened by the dealer.
- 3 Browse for web address <http://jharkhandcomtax.nic.in> and click on the image link Online Return Filing
- 4 Enter User Name as Dealer's TIN , Password received from department in step (1) and Security code shown as image , then Click on Login. On the first login, dealer must change login password.
- 5 After filing the return's details , click on [Save] or [Submit to Department] button then an acknowledgement no will be generated.
- 6 Click on [Save] button to make the form available for editing by the dealer.
- 7 Click on [Submit to Department] button , to finally submit it for further processing, return will not be then available for editing.
